H.E. NISHIMURA Yasutoshi
Minister of Economy, Trade and Industry (METI)
Japan

Mr. Nishimura Yasutoshi was appointed Minister of Economy, Trade and Industry (METI) on August 10, 2022. He also assumed the roles of Minister in charge of the Response to the Economic Impact caused by the Nuclear Accident, Minister for Green Transformation, Minister in charge of Industrial Competitiveness, Minister for Economic Cooperation with Russia, and Minister of State for the Nuclear Damage Compensation and Decommissioning Facilitation Corporation.

Between 2019 and 2021, Mr. Nishimura served as Minister in charge of Economic Revitalization. At this time, he also held ministerial positions overseeing social security reform and measures to address COVID 19 infections in Japan.

Mr. Nishimura also studied in the US, graduating from Graduate School of Public Policy, University of Maryland. He was born on October 15, 1962, in Hyogo Prefecture, in Japan's Kansai region.

Affairs in the State of Qatar, and the President & CEO of QatarEnergy. Mr. Al-Kaabi holds a Bachelor of Science degree in Petroleum & Natural Gas Engineering from Pennsylvania State University.

Since joining the company, Mr. Al-Kaabi held several key technical, commercial, and managerial positions before being appointed as the Director of the Oil & Gas Ventures.

Executive Director, International Energy Agency (IEA)
France

Dr. Fatih Birol (@fbirol) has served as Executive Director of the International Energy Agency since 2015. After taking office, Dr. Birol led the IEA in its first comprehensive modernisation programme since its creation in 1974. These efforts focused on "opening the doors" of the IEA to major emerging economies; making the IEA the global hub for clean energy transitions; and broadening the IEA's energy security mandate beyond oil to also cover electricity, natural gas, renewables and the critical minerals needed in many of today's clean energy technologies. Dr. Birol has been named in the TIME100, TIME's annual list of the world's most influential people. He is the recipient of numerous state decorations, including the French Legion of Honour, the Japanese Emperor's Order of the Rising Sun, the Order of the Polar Star from the King of Sweden and the highest Presidential decorations from Austria, Germany and Italy.

<u>Dr. Daniel Yergin</u> Vice Chairman, S&P Global United States of America

Dr. Daniel Yergin is a highly respected authority on energy, international politics, and economics, and a Pulitzer Prize winner. He is Vice Chairman of S&P Global, with 35,000 employees around the world, and is chairman of S&P Global's CERAWeek conference. Dr. Yergin is a member of the board of the Council on Foreign Relations, a senior trustee of the Brookings Institution, and a member of the Dallas Federal Reserve's Energy Advisory Council and of the Energy Think Tank of the government of India. of India. He served on the U.S. Secretary of Energy Advisory Board under four presidents and, for a decade, was a member of the Singapore International Energy Panel. He holds a BA from Yale University and a Ph.D. from Cambridge University, where he was a Marshall Scholar.

Mr. Hosaka has served as Commissioner since July 2020. As head of the agency, he oversees all areas of energy policy including developing Japan's Strategic Energy Plan, assuring secure energy supply, regulating the electricity & gas sectors, as well as promoting renewable energy and conservation. During his career, he has held various posts, including Director-General of the Trade and Economic Cooperation Bureau. He is a graduate of the University of Tokyo's Department of Economics, Faculty of Economics, and also studied at the University of Michigan in the United States.

His analysis and insights have earned him a position on several Japanese government and corporate advisory committees, including Tokyo Governor Yuriko Koike's Advisory team. He serves on the Board of Directors of OIST (Okinawa Institute of Science & Technology) and is the Chairman of the Asia Society Japan Policy Committee. He also sits in three Japan-based bio- and tech startups. Jesper is an economist, angelinvestor, patron; and yes, a Japan Optimist.

He is also a former tank commander with the U.S. Army's highly decorated 11th Armored Cavalry Regiment and has been awarded Distinguished Public Service awards by the U.S. government.
